## Preparation for the User Requirements Workshop

Engagement with you, our stakeholders, is a key objective of OME2. By taking on board your feedback, as well as informing you of the project aims and outcomes, we aim to meet our goal which is to ensure that the National Mapping and Cadastral datasets that are available continue to meet your requirements.

In order to make the most of the User Requirements Workshop we encourage you to view and use the HVLSP prior to the workshop. A first version of the prototype is available on the OME interface: <a href="https://www.mapsforeurope.org/access-data">https://www.mapsforeurope.org/access-data</a> as Web Services via WFS, WMS, and WMTS and as a download in Geopackage format. Version one provides 1: 10 000 scale authoritative administrative boundary and transport themes for Belgium, France and The Netherlands.

The Open Cadastral Map (OCM) comprises four data types: Administrative Units, Cadastral Parcels (and Cadastral Zones), Buildings (and Building Parts) and Addresses. Please note not all countries have all datasets/layers available within this map. The Open Cadastral Map is available as a Web Service via WMS and WMTS. The OCM is not provided for download, download is available directly from our data providers.

## During the workshop we will discuss the following questions with you:

#### Questions about the HVLSP

- 1. How does the changing European context impact your data requirements? For example: do you foresee security issues with open data?
- 2. Could the OME2 HVLSP suit your needs?
  - a. If yes, can you describe how you plan to use it? (Background mapping, analysis, overlay OME2 web services with your own data...)
  - b. If no, can you indicate what is missing for your own use?

- 3. In which format would you use the data? (WMS, WMTS, WFS, GeoPackage, other)
- 4. Do you have any feedback on the data model? (e.g. including highlighting additional information which you would like to have)
- 5. Did you encounter any difficulty to access the data?
- 6. What specific information would you like to know about the quality of the data?
- 7. How important is visualisation / styling to you? Do you prefer to visualise data yourself, or would you rather use styling provided by the project?

## Questions about the Open Cadastral Map:

- 8. In which format would you use the OCM? (WMS, WMTS, other)
- 9. Do you have any feedback on the OCM?
- 10. Did you encounter any difficulty to access the data?

#### Questions following feedback provided at User Requirements Workshop One:

- 11. Most users indicated a preference not to generalise to their desired scale from a single large-scale dataset, why is this?
- 12. If EuroBoundaryMap does not meet your user requirements, can you please explain why?
- 13. What types of metadata are most beneficial to you?

#### Questions on Sustainability of the HVLSP

To support our longer-term goals for the HVLSP we need to understand the user base more thoroughly. We would appreciate your responses to the following questions to support this work.

- 14. If the coverage of the HVLSP was extended to EU27 would that be enough for you to include it in your business-as-usual activities? If not, what coverage would you require?
- 15. Do the three current themes of the HVLSP meet your current user requirements? What other themes would you need to facilitate your work?
- 16. In the future we may be able to generalise this data to create different datasets of different scales. Is the scale of 1:10K suitable for your work? Would you require any other smaller scales and if so, at what scale?
- 17. Can you confirm if you and your colleagues require this dataset in your work? Please give some examples of what it could be used for and the impact that would have on your work (e.g. saves time as data is easily available and accessible, it comes from official sources etc).
- 18. Not all our members have this data available as open. We are exploring how we could include that data in our plans. Does your department have the facility to procure data if necessary?
